It was approved to invite the 2008 DGM's to the June meeting. It was also approved that we invite the 2009 DGM's to our December Christmas meeting.

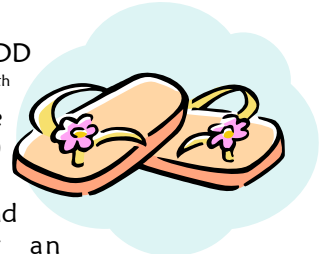
NEW BUSINESS: None
